Our shelter provides safe housing, daily care, socialization, enrichment, and medical treatment for homeless animals while they await adoption into loving homes. Every adoptable animal is vaccinated, tested, microchipped, spayed or neutered, and given necessary preventative care prior to placement. We serve our community by accepting strays and owner-surrendered pets, partnering with other rescues for animal transfers, reuniting lost pets with their families, and offering emergency boarding during crises such as natural disasters, temporary homelessness, or domestic violence situations. Additional community support services include a Pet Food Bank to assist families in need and low-cost nail trimming services to help pets remain healthy and in their homes.

4b (Code:) (Expenses \$ 217,518. including grants of \$) (Revenue \$ 263,393.) Through our Hope Clinic, we provide low-cost veterinary services designed to reduce pet homelessness and prevent the spread of disease through affordable, accessible care. Core services include spay and neuter surgeries for both shelter and community pets, Trap-Neuter-Return (TNR) for community cats, vaccinations, microchipping, and basic wellness services for shelter animals.

4c (Code:) (Expenses \$ 42,559. including grants of \$) (Revenue \$) Our Re"tail" Store offers a variety of pet supplies to help families care for their current pets or prepare for a new adoption. The store also serves as the welcoming front door to our organization. Staff and volunteers assist guests with purchases, adoptions, clinic appointments, and questions, ensuring every visitor receives guidance and support.
