Our shelter provides housing, daily care, socialization and enrichment, and medical care to homeless animals while they await finding their new adoptive families. All animals that are put up for adoption are brought up to date on vaccinations, receive routine tests and preventative care, are microchipped and are sprayed or neutered prior to adoption. We accept community strays and owner surrendered animals, we coordinate reunion of lost animals with their owners and provide emergency boarding to the community during emergencies such as community disasters, temporary homelessness and for victims of domestic abuse.

4b (Code:) (Expenses \$ 158,126. including grants of \$) (Revenue \$ 57,099.)

Through our inhouse clinic we are able to quickly spay or neuter our resident animals, therefore speeding up the adoption process. We are also able to provide the public with a low cost option for sterilization, helping to decrease overpopulation in our community. We also offer a low cost vaccination clinic. All services are provided by a licensed veterinarian.

Our re"tail" store provides the community with pet supplies that may be needed to care for their existing animals or to prepare for their new pet. The re"tail" store is also the face of the organization, assisting all customers who enter our shelter whether it be to shop, adopt, for our clinic or simply calling with questions.
